If you are a job applicant, personal data which we may collect includes, without limitation, your:             <ol style="list-style-type: none"> <li>(a) name or alias, gender, NRIC/FIN or passport number, date of birth, nationality, and country and city of birth;</li> <li>(b) mailing address, telephone numbers, email address and other contact details;</li> <li>(c) resume, educational qualifications, professional qualifications and certifications and employment references;</li> <li>(d) employment and training history;</li> <li>(e) work-related health issues and disabilities; and</li> <li>(f) photographs.</li> </ol> </li>   <li>3. Collection, use and disclosure of personal data	<ol style="list-style-type: none"> <li>1. We generally collect personal data that (a) you knowingly and voluntarily provide in the course of or in connection with your employment or job application with us, or via a third party who has been duly authorised by you to disclose your personal data to us (your “authorised representative”, which may include your job placement agent), after (i) you (or your authorised representative) have been notified of the purposes for which the data is collected, and (ii) you (or your authorised representative) have provided written consent to the collection and usage of your personal data for those purposes, or (b) collection and use of personal data without consent is permitted or required by the PDPA or other laws. We shall seek your consent before collecting any additional personal data and before using your personal data for a purpose which has not been notified to you (except where permitted or authorised by law).</li> <li>2. If you are a job applicant, your personal data will be collected and used by us for the following purposes and we may disclose your personal data to third parties where necessary for the following purposes: <ul style="list-style-type: none"> <li>(a) assessing and evaluating your suitability for employment in any current or prospective position within the organisation; and</li> <li>(b) verifying your identity and the accuracy of your personal details and other information provided.</li> </ul> </li> <li>3. If you are an employee, your personal data will be collected and used by us for the following purposes and we may disclose your personal data to third parties where necessary for the following purposes: <ul style="list-style-type: none"> <li>(a) performing obligations under or in connection with your contract of employment with us, including payment of remuneration and tax;</li> <li>(b) all administrative and human resources related matters within our organisation, including administering payroll, granting access to our premises and computer systems, processing leave applications, administering your insurance</li> </ul> </li> </ol>

Access to and correction of personal data	<ol style="list-style-type: none"> <li>1. If you wish to make (a) an access request for access to a copy of the personal data which we hold about you or information about the ways in which we use or disclose your personal data, or (b) a correction request to correct or update any of your personal data which we hold, you may submit your request in writing or via email to our Data Protection Officer at the contact details provided below.</li> <li>2. A reasonable time frame should be set, and there should not be any unjustified delay in effecting the withdrawal request. Generally, as a rough gauge, the time frame to be indicated should stay within 30 days of the withdrawal request.</li> </ol>

	<p>3. Please note that a reasonable fee may be charged for an access request. If so, we will inform you of the fee before processing your request.</p> <p>4. We will respond to your access request as soon as reasonably possible. Should we not be able to respond to your access request within 30 days after receiving your access request, we will inform you in writing within 30 days of the time by which we will be able to respond to your request. If we are unable to provide you with any personal data or to make a correction requested by you, we shall generally inform you of the reasons why we are unable to do so (except where we are not required to do so under the PDPA).</p> <p>5. Please note that depending on the request that is being made, we will only need to provide you with access to the personal data contained in the documents requested, and not to the entire documents themselves.<sup>2</sup> In those cases, it may be appropriate for us to simply provide you with confirmation of the personal data that our organisation has on record, if the record of your personal data forms a negligible part of the document.</p>
Withdrawal of consent	<p>1. The consent that you provide for the collection, use and disclosure of your personal data will remain valid until such time it is being withdrawn by you in writing. If you are a job applicant, you may withdraw consent and request us to stop using and/or disclosing your personal data for any or all of the purposes listed above by submitting your request in writing or via email to our Data Protection Officer at the contact details provided below.</p> <p>2. Upon receipt of your written request to withdraw your consent, we may require reasonable time (depending on the complexity of the request and its impact on our relationship with you) for your request to be processed and for us to notify you of the consequences of us acceding to the same, including any legal consequences which may affect your rights and liabilities to us. In general, we shall seek to process and effect your request within 7 days upon receiving it.</p> <p>3. Whilst we respect your decision to withdraw your consent, please note that depending on the nature and extent of your request, we may not be in a position to process your job application (as the case may be). We shall, in such circumstances, notify you before completing the processing of your request (as outlined above). Should you decide to cancel your withdrawal of consent, please inform us in writing in the manner described in clause 10 above.</p>
